DEED OF VARIATION

The parties to this Deed are:

(2) Thriftwood School a charitable company incorporated in England and Wales with registered number 07747149 (“the Academy”).

INTRODUCTION

- A. The Parties entered into a funding agreement dated 1st October 2011 (“the Funding Agreement”) relating to the establishment, maintenance and funding of an independent school known as Thriftwood School.
- B. The Parties now wish to vary and amend the terms of the Funding Agreement and wish to record their agreement as to such variations/amendments to the Funding Agreement by this Deed.
